# **OVERVIEW:**

In addition, they sought to fully realize the savings in quantities needed to plan and execute development programs as well as keep pace with ever-changing international regulations.

# PROTOCOL DESIGN:

First, to digitalize paper-based processes, the company implemented Signant's web-based Electronic Batch Record (EBR) solution to streamline configuration, execution, and reconciliation of manufacturing/packaging batch records. The EBR application also helps the company efficiently track statuses, maintain a comprehensive history, and enables reuse of master batch records across multiple projects.

Next, the implementation of Signant's Planning, Materials & Distribution (PMD) application expanded product distribution capabilities by increasing visibility into the supply chain for site shipments and depot-to-depot transfers. Finally, the company also improved its warehouse management capabilities by leveraging Signant's Warehouse Management System (WMS) application, which supports distribution activities through more efficient approaches including free picking and pick-and-pack fulfillment.
